HAZARDS CAUSED BY EXPOSURE IN THE EVENT OF FIRE

GENERAL INFORMATION

7.1. Precautions for safe handling.

vapour accumulation is therefore to be avoided by leaving windows and doors open and ensuring good cross ventilation. Do not eat, drink or smoke during use. Do not breathe spray.
